

MOUNTAIN VIEW CEMETERY, SHREWSBURY
Important Information for Lot Owners



USE OF LOTS Lots are intended for the burial of those immediate family members listed as anticipated burials by the lot owner at the time of lot purchase.

PAYMENTS Payment for the lot purchase (including perpetual care) is due in full at the time of purchase. Please refer to sale of lot sheet for refund policy.

LIMIT OF LOTS Purchase of lots is limited to **one purchase** per household.

CARE OF LOTS Perpetual care payments provide for the mowing and trimming, by the Cemetery staff, of the cemetery lawns. Maintenance and repair of markers, monuments, foundations, plantings, and shrubs and other items on a lot are fully the responsibility of the lot owner.

SHRUBS AND FLOWERBEDS Maintenance of all lot plantings is the responsibility of the owner. Shrubs are limited to 2 per lot and must be kept trimmed at all times. A fee is charged against any lot with shrubs that are not neatly trimmed. Shrubs that are judged to be either unsightly or over-sized may be removed by the Cemetery at the lot owner's expense. **Flower beds** may not exceed the width of the monument or the marker, nor exceed more than one foot in depth. Beds must be kept weed free by the lot owner at all times. Unsightly beds are subject to a penalty charge and removal. Planting to the rear of the monument are not allowed. Please refer to rule book for more details on plantings.

DECORATIONS Summer decorations are allowed between May 10 and October 10, and winter decorations between November 15 and April 1. Decorations are permitted from the Wednesday before to the Wednesday following Easter. **Decorations remaining after those times will be removed and discarded.**

MONUMENTS The central monument or flat marker on a lot must conform in size to the dimensions specified in the Cemetery rule book and must bear the **FAMILY NAME of the LOT OWNER ON RECORD ON FRONT. Sketch of monument must be signed by lot owner and sent to office and approved prior to installation.**

RULES AND REGULATIONS Complete Cemetery rules and regulations are contained in the Cemetery Rule book and it is the responsibility of each lot owner to obtain and be familiar with the latest version of the document. Lot owners are responsible for the future updates and rule changes.
